**RESOLUTION AMENDING FISCAL YEAR BUDGET 2023-2024  
RE: SHERIFF'S DEPARTMENT- SRO GRANT**

WHEREAS, on August 28, 2023 The Washington County Board of County Commissioners approved Resolution 23-08-11, Ratifying the Acceptance of the School Resource Officer (SRO) Grant Program Between the State of Tennessee, Department of Safety and Homeland Security and Washington County Sheriff's Office was approved; and

WHEREAS, the SRO Grant- Money to be expended after salary and benefit cost are calculated; and

WHEREAS, Revenue was budgeted but the expense was not; and

WHEREAS, the Sheriff's Office requests the following amendments to Fiscal Year Budget 2023-2024:

1. Increase \$73,000.00 to expense line item 101-54110-716 (Sheriff's Department- Law Enforcement Equipment);
2. Decrease \$73,000.00 from equity line item 101-39000 (Fund Balance); and

WHEREAS, at its February 1, 2024 meeting the Public Safety Committee recommended consideration and approval of this request; and

WHEREAS, the Budget Committee at its February 2, 2024 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2023-2024 is amended to:

1. Increase \$73,000.00 to expense line item 101-54110-716 (Sheriff's Department- Law Enforcement Equipment).
2. Decrease \$73,000.00 from equity line item 101-39000 (Fund Balance).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


