RESOLUTION AMENDING FISCAL YEAR BUDGET 2023-2024 RE: SHERIFF'S DEPARTMENT- SALARY SUPPLEMENT

WHEREAS, the STATE OF TENNESSEE Peace Officer Standards and Training Commission (POST) offers certification of full-time commissioned law enforcement officers who have complied with minimum training standards and provides a supplemental training stipend to those officers who have successfully completed annual training; and

WHEREAS, the Sheriff's Office requests the following amendments to Fiscal Year Budget 2023-2024 for Salary Supplements:

1. Increase \$800.00 to expense line item 101-53920-140 (Courtroom Security- Salary Supplements);
2. Increase \$71,200.00 from expense line item 101-54110-140 (Sheriff's Department- Salary Supplements);
3. Increase \$79,200.00 from revenue line item 101-46210 (Law Enforcement Training Programs); and

WHEREAS, at its February 1, 2024 meeting the Public Safety Committee recommended consideration and approval of this request; and

WHEREAS, the Budget Committee at its February 2, 2024 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2023-2024 is amended to:

1. Increase \$800.00 to expense line item 101-53920-140 (Courtroom Security- Salary Supplements);
2. Increase \$71,200.00 from expense line item 101-54110-140 (Sheriff's Department- Salary Supplements);
3. Increase \$79,200.00 from revenue line item 101-46210 (Law Enforcement Training Programs); and


