## RESOLUTION NO. 24-04-13

### **RESOLUTION AMENDING FISCAL YEAR BUDGET 2023-2024 RE: EMERGENCY MANAGEMENT AGENCY- PURCHASE OF 2024 CHEVY TAHOE**

WHEREAS, the Emergency Management Agency requests the purchase of a 2024 Chevy Tahoe to replace the 2012 Chevy Tahoe with \$40,000.00 budgeted in Capital Projects funds and \$9,616.00 to be transferred from the General Fund to Capital Projects:

1. Increase \$9,616.00 to revenue line item 171-49800 (Transfers In);
2. Increase \$9,616.00 to expense line item 171-91130-718 (Public Safety projects- Motor Vehicles);
3. Increase \$9,616.00 to expense line item 101-54410-590 (Civil Defense- Transfers to Other Funds);
4. Decrease \$9,616.00 from equity line item 101-34525-822 (Restricted for Public Safety); and

WHEREAS, the Budget Committee at its April 10, 2024 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2023-2024 is amended to:

1. Increase \$9,616.00 to revenue line item 171-49800 (Transfers In).
2. Increase \$9,616.00 to expense line item 171-91130-718 (Public Safety projects- Motor Vehicles).
3. Increase \$9,616.00 to expense line item 101-54410-590 (Civil Defense- Transfers to Other Funds).
4. Decrease \$9,616.00 from equity line item 101-34525-822 (Restricted for Public Safety).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


