RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025 RE: SHERIFF'S OFFICE- SALARY SUPPLEMENT FOR 2024

WHEREAS, the Sheriff's Office requests the following amendments to Fiscal Year Budget 2024-2025:

1. Increase \$7,200.00 to expense line item 101-53920-140 (Courtroom Security- Salary Supplements);
2. Increase \$65,600.00 to expense line item 101-54110-140 (Sheriff's Department- Salary Supplements);
3. Increase \$800.00 to expense line item 101-55720-140 (Sanitation Education/Information-Salary Supplements);
4. Increase \$73,600.00 to revenue line item 101-46210 (Law Enforcement Training Programs); and

WHEREAS, at its September 5, 2024 meeting the Public Safety Committee recommended consideration and approval of this request; and

WHEREAS, the Budget Committee at its September 11, 2024 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2024-2025 is amended to:


1. Increase \$7,200.00 to expense line item 101-53920-140 (Courtroom Security- Salary Supplements).
2. Increase \$65,600.00 to expense line item 101-54110-140 (Sheriff's Department- Salary Supplements).
3. Increase \$800.00 to expense line item 101-55720-140 (Sanitation Education/Information-Salary Supplements).
4. Increase \$73,600.00 to revenue line item 101-46210 (Law Enforcement Training Programs).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


