### **RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025 RE: COURTROOM SECURITY AT THE GEORGE JAYNES JUSTICE CENTER- PAID UP LIFE INSURANCE**

WHEREAS, the Mayor / Human Resources requests the following amendments to Fiscal Year Budget 2024-2025:

1. Increase \$2,930.00 to expense line item 101-53920-206 (Courtroom Security-Life Insurance);
2. Decrease \$2,930.00 from equity line item 101-39000 (Fund Balance); and

1. Increase \$2,930.00 to expense line item 101-53920-206 (Courtroom Security-Life Insurance).
2. Decrease \$2,930.00 from equity line item 101-39000 (Fund Balance).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
