## RESOLUTION NO. 24-10-13

### **RESOLUTION AMENDING FISCAL YEAR 2025 BUDGET RE: SHERIFF'S OFFICE- PURCHASE OF K-9**

WHEREAS, the Sheriff's Office requests the following amendments to Fiscal Year 2025 Drug Fund Budget for the purchase of a K-9:

1. Decrease \$20,000.00 from equity line item 122-39000 (Unrestricted Fund Balance);
2. Increase \$20,000.00 to expense line item 122-54150-716 (Drug Enforcement- Law Enforcement Equipment); and

WHEREAS, at its October 10, 2024 meeting the Public Safety Committee recommended consideration and approval of this request; and

WHEREAS, the Budget Committee at its October 16, 2024 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year 2025 Budget is amended to:

1. Decrease \$20,000.00 from equity line item 122-39000 (Unrestricted Fund Balance).
2. Increase \$20,000.00 to expense line item 122-54150-716 (Drug Enforcement- Law Enforcement Equipment).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
