RESOLUTION NO. 24-11-08

RESOLUTION AMENDING FISCAL YEAR 2025 BUDGET RE: BOARD OF EDUCATION REIMBURSEMENT FOR MAINTENANCE OF THE BOONES CREEK ATHLETIC FIELDS

WHEREAS, the Board of Education requests the following amendments to Fiscal Year Budget 2024-2025 for reimbursement of expenses incurred in 2024 (between February 1 and October 31) for the maintenance of the County's athletic fields in Boones Creek prior to the acceptance and approval of an interlocal agreement effective November 1, 2024:

1. Increase \$60,000.00 to expense line item 171-91150-399 (Social, Cultural, and Recreation Projects - Other Contracted Services);
2. Decrease \$60,000.00 from equity line item 171-39000 (Fund Balance- Unassigned); and

WHEREAS, at its November 7, 2024 meeting the Health, Education & Welfare Committee considered the request with no recommendation to the Budget Committee; and

WHEREAS, the Budget Committee at its November 13, 2024 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2024-2025 is amended to:

1. Increase \$60,000.00 to expense line item 171-91150-399 (Social, Cultural, and Recreation Projects - Other Contracted Services).
2. Decrease \$60,000.00 from equity line item 171-39000 (Fund Balance- Unassigned).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
