RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025 RE: SHERIFF'S OFFICE- INSURANCE RECOVERY- SHERIFF'S DEPUTY'S CRUISERS

WHEREAS, the Sheriff's Office requests a budget amendment to account for insurance recovery associated with damaged Sheriff Deputy's cruisers; and

WHEREAS, the Sheriff's Office requests the following amendments to Fiscal Year Budget 2024-2025:

1. Increase \$41,072.00 to expense line item 101-54110-338 (Sheriff's Department-Maintenance and Repair Services - Vehicles);
2. Increase \$41,072.00 to revenue line item 101-49700 (Insurance Recovery); and

WHEREAS, at its January 9, 2025 meeting the Public Safety Committee recommended consideration and approval of this request; and

WHEREAS, the Budget Committee at its January 15, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2024-2025 is amended to:

1. Increase \$41,072.00 to expense line item 101-54110-338 (Sheriff's Department-Maintenance and Repair Services - Vehicles).
2. Increase \$41,072.00 to revenue line item 101-49700 (Insurance Recovery).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.




