## RESOLUTION NO. 25-01-17

### **RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025 RE: ZONING OFFICE- TEMPORARY PERSONNEL**

WHEREAS, Due to the increased permit activity resulting from Hurricane Helene, current staffing in the Washington County Zoning Office is insufficient to effectively process permits and manage other administrative needs; and

WHEREAS, the Zoning Office requests the following amendments to Fiscal Year Budget 2024-2025 to provide for using personnel from a temporary employment agency:

1. Increase \$15,500.00 to expense line item 101-51750-312-024 (Codes Compliance- Contracts with Private Agencies);
2. Decrease \$15,500.00 from equity line item 101-39900 (Fund Balance); and

WHEREAS, the Budget Committee at its January 15, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year 2025 Budget is amended to:

1. Increase \$15,500.00 to expense line item 101-51750-312-024 (Codes Compliance- Contracts with Private Agencies).
2. Decrease \$15,500.00 from equity line item 101-39900 (Fund Balance).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
