RESOLUTION NO. 25-02-07

RESOLUTION APPROVING AND AUTHORIZING CERTAIN CAPITAL PROJECTS FUND SPENDING UP TO \$11,000.00 IN FY25 FOR SHERIFF'S OFFICE – DATTO SERVER UPGRADE/REPLACEMENT

WHEREAS, the Capital Projects Funds Policy, adopted August 29, 2016 (Resolution 16-08-14), requires an enabling Resolution approved by the County Commission, identifying a specific project or use of capital funds prior to expenditure or transfer from the Capital Projects Fund; and

WHEREAS, the Sheriff's Office requests authorization to spend up to \$11,000.00 of budgeted funds for DATTO server upgrades/replacement in FY25 from the County's Capital Project Fund, 171-91130-709, Public Safety Projects-Data Processing Equipment; and

WHEREAS, at its February 6, 2025 meeting the Public Safety Committee recommended consideration and approval of this request; and

WHEREAS, at its February 12, 2025 meeting the Budget Committee recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. The Board of County Commissioners approves and authorizes the expenditure in an amount not to exceed \$11,000.00, from expense line item 171-91130-709, Public Safety Projects- Data Processing Equipment, for DATTO server upgrades/replacement.

SECTION 2. The County Purchasing Agent and County Mayor are authorized to execute all necessary documents, subject to the approval of the County Attorney.

SECTION 3. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
