RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025 RE: RECOVERY COURT – INCREASE IN MENTAL HEALTH & SUBSTANCE ABUSE GRANT

WHEREAS, the Recovery Court Administrator requests the following amendments to Fiscal Year Budget 2024-2025 for an increase in the Mental Health & Substance Abuse grant to fund attendance at the All Rise conference; and

1. Increase \$11,600.00 to revenue line item 101-46980-241 (Other State Grants);
2. Increase \$2,685.00 to expense line item 101-53330-356-241 (Drug Court- Tuition);
3. Increase \$8,915.00 to expense line item 101-53330-355-241 (Drug Court- Travel); and

WHEREAS, the Budget Committee at its March 12, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2024-2025 is amended to:

1. Increase \$11,600.00 to revenue line item 101-46980-241 (Other State Grants).
2. Increase \$2,685.00 to expense line item 101-53330-356-241 (Drug Court- Tuition).
3. Increase \$8,915.00 to expense line item 101-53330-355-241 (Drug Court- Travel).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
