***RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025
RE: SOLID WASTE – AIR CURTAIN INCINERATOR***

WHEREAS, The First Tennessee Development District is applying for a grant for use by Solid Waste to acquire an air curtain incinerator to reduce county brush waste that goes to the landfill; and

WHEREAS, the incinerator is planned for the Lamar convenience center site; and

WHEREAS, the grant is expected to be non-matching; and

WHEREAS, the Solid Waste Director requests the following amendments to Fiscal Year Budget 2024-2025 to acquire an air curtain incinerator, subject to grant award:

1. Increase \$150,000.00 to expense line item 116-55732-733 (Convenience Centers- Solid Waste Equipment);
2. Increase \$150,000.00 to revenue line item 116-46170 (Solid Waste Grants);

WHEREAS, the Public Works Committee at its March 6, 2025 meeting recommended consideration and approval of this request; and

WHEREAS, the Budget Committee at its March 12, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:


SECTION 1. Fiscal Year Budget 2024-2025 is amended to:

1. Increase \$150,000.00 to expense line item 116-55732-733 (Convenience Centers- Solid Waste Equipment);
2. Increase \$150,000.00 to revenue line item 116-46170 (Solid Waste Grants);






