RESOLUTION AMENDING FISCAL YEAR BUDGET 2024-2025 RE: CIRCUIT COURT CLERK- AUDIO/VISUAL EQUIPMENT

WHEREAS, the Circuit Court Clerk requests the following amendments to Fiscal Year Budget 2024-2025 for the use of Data Processing Reserve for Audio/Visual Equipment:

1. Increase \$10,000.00 to expense line item 101-53100-709-815 (Circuit Court- Data Processing Equipment);
2. Decrease \$10,000.00 from equity line item 101-34520-815 (Restricted for Administration of Justice); and

WHEREAS, the Budget Committee at its March 12, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2024-2025 is amended to:

1. Increase \$10,000.00 to expense line item 101-53100-709-815 (Circuit Court- Data Processing Equipment).
2. Decrease \$10,000.00 from equity line item 101-34520-815 (Restricted for Administration of Justice).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
