RESOLUTION NO. 25-04-12

RESOLUTION APPROVING AND AUTHORIZING CERTAIN CAPITAL PROJECTS FUND SPENDING UP TO \$149,101.00 IN FY25 TO COMPLETE LOCK UPGRADE PROJECT AND AMENDING FISCAL YEAR BUDGET 2024-2025

WHEREAS, The 5-Year Capital Project Plan contemplated replacing jail locks in FY25, FY26 and FY27. The project was bid in March at a total cost of \$278,926; and

WHEREAS, Resolution 25-01-09 authorized spending of up to \$150,000 of budgeted Capital Projects funds in FY25 for the project; and

WHEREAS, the Sheriff requests authorization to spend additional amounts up to \$149,101.00 to fully fund the project; for FY24-FY25 from the County's Capital Project Fund, 171-91130-707, Public Safety Projects- Building Improvements; and

WHEREAS, the Capital Projects Funds Policy, adopted August 29, 2016 (Resolution 16-08-14), requires an enabling Resolution approved by the County Commission, identifying a specific project or use of capital funds prior to expenditure or transfer from the Capital Projects Fund; and

WHEREAS, the Sheriff requests the following amendments to Fiscal Year Budget 2024-2025:

1. Increase \$149,101.00 to expense line item 171-91130-707 (Public Safety Projects- Building Improvements);
2. Decrease \$149,101.00 from equity line item 171-39000 (Fund Balance); and

WHEREAS, at its April 9, 2024 meeting the Budget Committee recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. The Board of County Commissioners approves and authorizes an appropriation of \$149,101.00 to the Washington County Sheriff's Office to be funded from expense line item 171-91130-707, Public Safety Projects- Building Improvements, to fully fund the lock upgrade project.

SECTION 2. The County Purchasing Agent and County Mayor are authorized to execute all necessary documents, subject to the approval of the County Attorney.

SECTION 3. Fiscal Year Budget 2024-2025 is amended to:

1. Increase \$149,101.00 to expense line item 171-91130-707 (Public Safety Projects- Building Improvements).
2. Decrease \$149,101.00 from equity line item 171-39000 (Fund Balance).

SECTION 4. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
