## RESOLUTION NO. 25-08-15

### **RESOLUTION AMENDING FY26 BUDGET TO ACCEPT A NON-MATCHING GRANT: SOLID WASTE- STATE EQUIPMENT GRANT**

WHEREAS, Resolution No. 25-05-19 approved and authorized the County Mayor to execute non-matching grant agreements on behalf of Washington County; and

WHEREAS, the Solid Waste Director requests the following amendments to FY26 related to four Tennessee non-matching, reimbursing solid waste equipment grants which have been executed by the County Mayor under the authority of Resolution No. 25-05-19:

1. Increase \$802,430.00 to expense line item 116-55732-733 (Convenience Centers- Solid Waste Equipment);
2. Increase \$802,430.00 to revenue line item 116-46170 (Solid Waste Grants); and

WHEREAS, the Budget Committee at its August 13, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year 2025-2026 Budget is amended to:

1. Increase \$802,430.00 to expense line item 116-55732-733 (Convenience Centers- Solid Waste Equipment).
2. Increase \$802,430.00 to revenue line item 116-46170 (Solid Waste Grants).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
