## RESOLUTION NO. 25-09-19

### ***RESOLUTION AMENDING FY26 BUDGET RE: ARCHIVES- HVAC UNIT***

WHEREAS, the County Archivist has advised that the rooftop HVAC on the Washington County Archives building leaks freon at a fairly rapid rate. The Washington County Maintenance Director continues to investigate viability of repair or replacement options which would require funding; and

WHEREAS, the Archives Department requests the following amendments to FY26 to fund a new HVAC unit:

1. Increase \$70,000.00 from expense line item 101-51910-707 (Preservation of Records- Building Improvements);
2. Decrease \$70,000.00 from equity line item 101-34710-000-852 (Assigned for General Government- Preservation of Records Reserve); and

WHEREAS, if repair is viable and replacement is not required, any unused budgeted funds will revert to the Archive Department restricted reserve fund.

WHEREAS, the Budget Committee at its September 10, 2025 meeting recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year 2025-2026 Budget is amended to:

1. Increase \$70,000.00 from expense line item 101-51910-707 (Preservation of Records- Building Improvements).
2. Decrease \$70,000.00 from equity line item 101-34710-000-852 (Assigned for General Government- Preservation of Records Reserve).

SECTION 2. Unused funding reverts to the Archive Department restricted reserve fund.

SECTION 3. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


